A meeting of the TIF Finance Committee was held, Wednesday, March 5, 2025 at 4:15 o'clock p.m. at the Council Chambers, City Offices, 100 E. 4th Street, York, Nebraska.

Notice of this meeting was published in the York New Times on February 26, 2025. The Mayor announced the Open Meetings Act was posted on the east wall of the Council Chambers.

Present were: Barry Redfern, Mark Way, Kim Stephens, Sue Crawford, Mike Bacon and Amanda Ring. Absent were: Jeff Pieper, Zac Holoch, Lisa Hurley and Charley Campbell.

Mike Bacon spoke on redevelopment plan to the TIF Finance Committee with his knowledge from drafting the TIF paperwork. He stated the ROI without TIF is approximately 8.61% and with TIF it is 12.21%. This return on investment is a reasonable rate for a development project of this magnitude. There was conversation had regarding the TIF eligible expenses and the total TIF amount to be approved. This is for the redevelopment of Lot 2, Block 1, Holthus Subdivision. It's located lot south of the Holthus Convention Center. This development, Hyatt Studios, will have approximately 109-120 rooms and employee 22 employees. TIF funds will be used for site development, infrastructure and parking lot expense. Construction is anticipated to start summer of 2025 and completion will take 12 months. Increased sales, lodging and occupation taxes will be a benefit to the city.

Stephens made a motion that the project would not be financially feasible without the tax increment financing and it is consistent with the comprehensive plan adopted by the City and it is consistent with legislative findings of the Nebraska Community Development Law. The motion was seconded by Way. . Roll call: Ayes: Redfern, Stephens, Way, Crawford, Bacon and Ring. Nays: none. Absent and not voting: Pieper, Hurley, Holoch and Campbell.

Ring made a motion to recommend the approval of the Hyatt Studios Redevelopment Plan to the Planning Commission and City Council. The motion was seconded by Way. Roll call: Ayes: Redfern, Stephens, Way, Crawford, Bacon and Ring. Nays: none. Absent and not voting: Pieper, Hurley, Holoch and Campbell.
