Project Name: York City Auditorium Gymnasium Floor Resurface

Required Specifications:

The selected contractor will complete a full resurfacing and redesign of the gymnasium floor, including:

Floor Resurfacing Requirements

- Sanding the entire gymnasium floor down to bare wood.
- Repair or replacement of broken boards and correction of large seam gaps caused by previous environmental conditions.
- Application of paint, stain, and finish coatings for a high-durability, professional-grade surface suitable for multipurpose use.

Court Markings & Artwork

Installation of new, clearly defined markings for:

- One (1) main basketball court
- One (1) main volleyball court
- Four (4) pickleball courts
- Two (2) half-court basketball courts

Center court must include a 14-foot "YORK" logo with a painted outline.

The completed floor must accommodate a diverse range of athletic events, community programs, and recreational activities.

Responsible Bidder Criteria:

Proposals must include the following:

1. Renderings or design options illustrating proposed line layouts and artwork.
2. Two (2) references for similar recently completed hardwood gym flooring projects.
3. Proof of insurance meeting required coverage standards.
