Project Name: York City Auditorium Stage Lights

Required Specifications:

Vendors must provide a full LED stage lighting system upgrade for the York City Auditorium, including: Lighting System Requirements

- Complete transition to an LED-based theatrical lighting system.
- Minimum of:
 - Three (3) onstage fixtures for vibrant and dynamic lighting.
 - Two (2) front-of-house fixtures for focused illumination, inclusive of protective cages.
- Installation must include wire relays at all fixtures to ensure efficient power and control distribution.
- Vendor must coordinate with a City-registered electrical contractor for connection to venuesupplied amp outlets and electrical installation.

Additional Requirements

- Removal and proper disposal of all existing lighting equipment.
- On-site training session for City staff upon project completion.
- Lighting system must accommodate varied performance and event types.

Responsible Bidder Criteria:

Proposals must include:

- 1. Theatrical lighting floor plan detailing fixture layout and system design.
- 2. Two (2) references for similar recently completed projects.
- 3. Proof of insurance meeting required coverage standards.
