Project Name: Install Electrical for Emergency Generator

Required Specifications:

- Install Electrical from a Cummins C200D6D, Diesel Genset, 60Hz, 200kW Generator to the Main Electrical Panels at the City of York Auditorium located at 612 North Nebraska Ave, York, NE 68467
 - This Generator will be utilized as an Emergency Generator for the building
 - Generator and Automatic Transfer Switch is on site
- All 811 calls are the responsibility of the contractor
- The contractor must comply with the Davis-Bacon Act and pay all laborers and mechanics the applicable
 prevailing wages and fringe benefits as determined by the Wage and Hour Division of
 the <u>U.S. Department of Labor</u>. This includes the basic hourly rate and any fringe benefits listed in the
 applicable wage determination for the specific job classification.
- Contractor must identify all potential trades to install equipment on the wage scale for the Davis-Bacon Act and include in bid package
- Buy America, Build America (BABA) self-certification for must be completed. Click here for Form
- Attach an hourly breakdown of labor cost
- Include an estimate of hours needed to complete the project
- Contractor will need to be present while generator manufacturer conducts commissioning of the generator
- Project needs to be completed prior to October 31, 2025.

- Manual for the Generator
- Location of Generator from the Building
- Concrete pad construction for the Generator and Automatic Transfer Switch
